

Copyright Transfer Agreement

We, the authors of this paper, hereby consent to the transfer of all exclusive and transferable copyrights pertaining to the content of this article, encompassing figures, tables, abstracts, and other extractable components, to the organizer of EYE SCIENCE at Sun Yat-sen University.
